

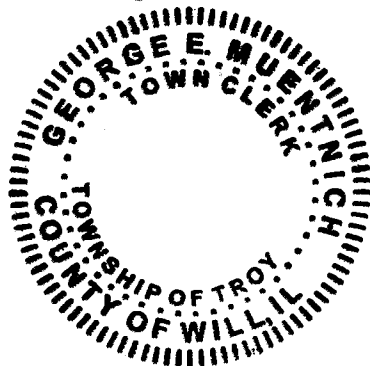
SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

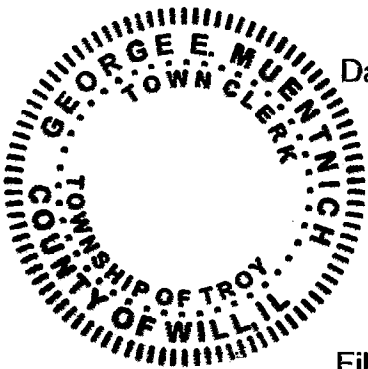
