**ORDINANCE No. 18-19-20**

An ordinance levying taxes for all town purposes for TROY Township,  
WILL County, Illinois, for the tax year 2018 , collectable in 2019.

BE IT ORDAINED by the Board of Trustees of TROY Township,

WILL County, Illinois, as follows:

SECTION 1: That the sum of One Million One Hundred Fifty Seven Thousand Twenty One Dollars & 92/100

(\$1,157,021.92) are hereby levied upon all

property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted

by the people in accordance with the law, for such purposes as:





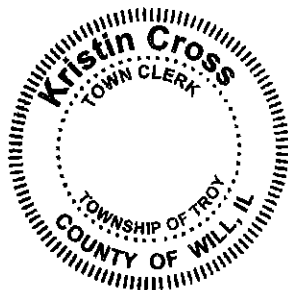
SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


