RESOLUTION 18-19R-18

2018 TAX LEVY ESTIMATE

TROY TOWNSHIP

WHEREAS, Troy Township is a non-home rule unit of government organized and operating under the authority of the Illinois Constitution and pursuant to the Illinois Township Code, and;

WHEREAS, 35 ILCS 200/18-60 states that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each taxing district shall determine the amounts of money, exclusive of any portion of that levy attributable to the cost of conducting an election required by the general election law, hereafter referred to as "election costs", estimated to be necessary to be raised by taxation for that year upon the taxable property in its district.

BE IT RESOLVED by the Supervisor and Board of Town Trustees (the "Board") of Troy Township, Will County, Illinois as follows:

SECTION ONE: RECITALS. The foregoing Recitals are incorporated as substantive portions hereof as though set forth herein.

SECTION TWO: The Troy Township extended annual tax levy for 2017, paid in 2018, was \$1,102,976.09.

SECTION TWO: That the Estimate of the Troy Township 2018 tax levy to be paid in 2019 is determined as follows:

SECTION THREE: That there is no need to hold a hearing pursuant to the Truth in Taxation Act, as the Estimate for the 2018 Tax Levy is not more than 105% of the previous fiscal year.

SECTION FOUR: SEVERABILITY. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.



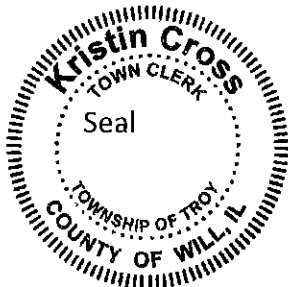
SECTION SIX: EFFECTIVE DATE. This Resolution shall be in full force and effect upon its passage and approval.


