

Minutes of the Troy Township Public Hearing

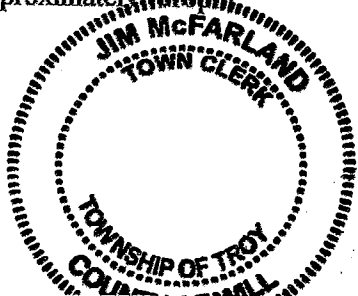
Supervisor Baltz asked for any public comments on Ordinance 12-13-02. After asking twice he asked for any Board questions or comments on either ordinance.


Hearing no discussion, Supervisor Baltz moved onto the Adoption of both Ordinances.
