

Minutes of the Troy Township Public Hearing

Monday, May 20, 2013

7:00 pm

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Joseph D. Baltz called the meeting to order. The Pledge of Allegiance was recited and lead by Trustee Larry Ryan.

Supervisor Baltz opened the public hearing stating the purpose of the hearing was to adopt the budgets of the 2013–2014 fiscal year which includes the Road District Budget and Appropriation Ordinance 13-14-06 and the Town Budget and Appropriation Ordinance 13-14-07.

Supervisor Baltz noted that Administrator Jennifer Dyluk, Highway Commissioner Ward and Assessor Anderson all worked on the budget and presented it to the Finance Committee for review and approval. Finance Committee Chairman Larry Ryan commented that the committee had a productive discussion on both budgets and slight changes were made that as Chairman, he feels will be very beneficial. It is Chairman Ryan's recommendation at this time to approve both budgets.

Supervisor Baltz asked three times for any public comments or comments from the Board on the Road and Bridge Budget and Appropriation Ordinance 13-14-06.

Hearing none, Supervisor Baltz presented the Town Fund Budget and Appropriation Ordinance 13-14-07 and asked for public comments. Supervisor Baltz asked three times for public comments. Hearing none, Supervisor Baltz asked for any Board comments.


Hearing none, Supervisor Baltz asked for a motion to approve.

Motion made by Trustee Wheeler; seconded by Trustee Ryan to adopt Ordinance 13-14-06 an Ordinance Appropriating for all Road Purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2013, and ending March 31, 2014. Roll call vote: Wheeler – Aye; Walden – Aye; Theobald – Aye, Ryan – Aye; Baltz – Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Ryan; seconded by Trustee Walden to adopt Ordinance 13-14-07 an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2013, and ending March 31, 2014. Roll call vote: Ryan – Aye; Walden – Aye; Theobald – Aye, Wheeler – Aye; Baltz – Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Theobald; seconded by Trustee Walden to adjourn. Meeting adjourned at 7:06pm.
