

Minutes of the Troy Township Public Hearing

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.


Hearing no questions, Supervisor Baltz asked for a motion to approve.

Motion made by Trustee Walden; seconded by Trustee Ryan to adopt Ordinance 15-16-04 an Ordinance Appropriating for all Road Purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2015, and ending March 31, 2016, with a total appropriation amount of \$1,486,220.00. Roll call vote: Ryan-Aye; Theobald-Aye; Walden-Aye, Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Theobald; seconded by Trustee Wheeler to adopt Ordinance 15-16-05 an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2015, and ending March 31, 2016, with a total appropriation amount of \$1,177,166.00. Roll call vote: Ryan-Aye; Theobald-Aye; Walden-Aye, Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Motion made by Trustee Ryan; seconded by Trustee Walden. Meeting adjourned at 7:05pm.
