

Minutes of the Troy Township Public Hearing

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Joseph D. Baltz called the meeting to order. The Pledge of Allegiance was recited and lead by Jerry Seil.

Citizen Jim Lynch stated that he thought the budget presentation was very readable and appreciates that the township spends tax payer dollars wisely.

Supervisor Baltz asked for questions or comments from the Board on the Road and Bridge Budget and Appropriation Ordinance 16-17-06. Administrator Dylik reported that no changes have been made since the tentative budgets were approved.

Supervisor Baltz asked for questions or comments from the Board on the Town Fund Budget and Appropriation Ordinance 16-17-07. Administrator Dylik reported that no changes have been made since the tentative budgets were approved.

Hearing no questions, Supervisor Baltz asked for a motion to approve.

Motion made by Trustee Walden; seconded by Trustee Wheeler to adopt Ordinance 16-17-06 an Ordinance Appropriating for all Road Purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2016, and ending March 31, 2017, with a total appropriation amount of \$1,485,870.00. Roll call vote: Ryan–Aye; Theobald–Absent; Walden–Aye, Wheeler–Aye; Baltz–Aye. 4 Ayes, 0 Nays, 1 Absent. Motion Carried.

Motion made by Trustee Ryan; seconded by Trustee Wheeler to adopt Ordinance 16-17-07 an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2016, and ending March 31, 2076, with a total appropriation amount of

\$1,097,865.00. Roll call vote: Ryan–Aye; Theobald–Absent; Walden–Aye, Wheeler–Aye; Baltz–Aye. 4 Ayes, 0 Nays, 1 Absent. Motion Carried.

Motion made by Trustee Ryan; seconded by Trustee Walden to adjourn. Meeting adjourned at 7:05pm.
