

Minutes of the Troy Township Public Hearing
Monday, April 17, 2017
7:00 pm

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Joseph D. Baltz called the meeting to order. The Pledge of Allegiance was recited and lead by Trustee Donald Walden.

Supervisor Baltz asked for any citizen comments.

After asking two more times the meeting was closed for citizen comments.

Supervisor Baltz asked for questions or comments from the Board on the Road and Bridge Budget and Appropriation Ordinance 17-18-01. Supervisor Baltz commented that Highway Commissioner Ward worked diligently with Administrator Dylík to prepare this proposed budget.

Supervisor Baltz asked for questions or comments from the Board on the Town Fund Budget and Appropriation Ordinance 17-18-02. Supervisor Baltz commented that he and Assessor Anderson worked with Administrator Dylík to prepare this proposed budget.

Trustee and Finance Committee Chairman Larry Ryan commented that everything was covered and addressed in the proposed budget presentation. Supervisor Baltz further commented that the Finance Committee had a very productive meeting on March 20, 2017 where the Committee reviewed the budgets in detail.

Supervisor Baltz asked for any final questions or discussion on either proposed budget.

Hearing no questions, Supervisor Baltz asked for a motion to approve.

Motion made by Trustee Ryan; seconded by Trustee Walden to adopt Ordinance 17-18-01 an Ordinance Appropriating for all Road Purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2017, and ending March 31, 2018 Roll call vote: Ryan–Aye; Theobald–Absent; Walden–Aye, Wheeler–Aye; Baltz–Aye. 4 Ayes, 0 Nays, 1 Absent. Motion Carried.

Motion made by Trustee Wheeler; seconded by Trustee Walden to adopt Ordinance 17-18-02 an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2017, and ending March 31, 2018. Roll call vote: Ryan-Aye; Theobald-Absent; Walden-Aye, Wheeler-Aye; Baltz-Aye. 4 Ayes, 0 Nays, 1 Absent. Motion Carried.

Motion made by Trustee Wheeler; seconded by Trustee Ryan to adjourn. Meeting adjourned at 7:05pm.
