

Sixteen bids were received. Clerk Cross opened the bids and read them aloud as follows:

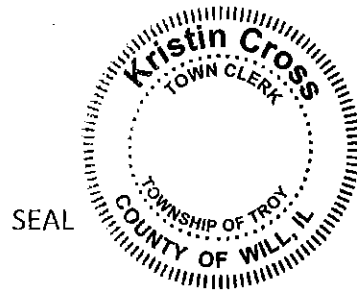
