ORDINANCE NO. 17-18-18

An ordinance levying taxes for all road purposes for TROY Road

District, WILL County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of TROY Township,
WILL County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of TROY Road District on DECEMBER 18, 2017 does hereby determine and declare that the sum of <u>One Million Three</u>
