**ORDINANCE NO. 20-21-13**

An ordinance levying taxes for all road purposes for TROY Road  
District WILL County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of TROY Township,

WILL County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of TROY Road District  
on DECEMBER 21, 2020 does hereby determine and declare that the sum of One Million Four  
Hundred Seventy One Thousand Nine Hundred and Sixty Nine Dollars & 61/100 (\$1,471,969.61) are hereby levied  
upon all property subject to taxation within the Road District as that property is assessed and equalized,  
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by  
statute or voted by the people in accordance with the law, for such purposes as:

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
