**TAX LEVY ORDINANCE
ROAD DISTRICT
ORDINANCE NO. 14-15-13**

An ordinance levying taxes for all road purposes for TROY Road District, WILL County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of TROY Township, WILL County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of TROY Road District on DECEMBER 15, 2014 does hereby determine and declare that the sum of One Million Two Hundred Thirty Four Thousand Two Hundred Twenty Two Dollars & 00/100 (\$1,234,220.00)

are hereby levied upon all property

subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

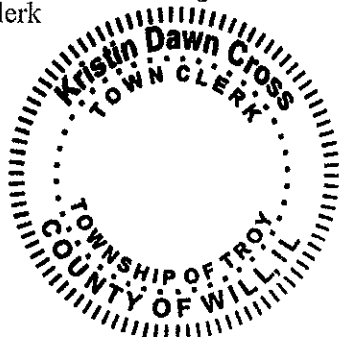
