Have you lived in another township that had a survey over the phone popular service that the residents loved? Do you know of a loved one who is benefiting from a service that their township provides? We want to hear from you.



NEWS FROM ASSESSOR Kim Anderson



As always, spring is a busy time for the Assessor's office. My staff will be out throughout the Township measuring new construction as well as performing other field checks. Township staff members can be identified by our vehicle that says Troy Township

on each door and by wearing Troy Township logoed clothing. Staff members will also have my business card with them and Township field check forms which includes a copy of your property record card. If you have any questions about why we are in your neighborhood, please do not hesitate to contact our office.

We are currently working on reassessments for 2017. Our neighborhood sales studies are showing us that market values in Troy Township are on the rise. We continue to add new homes, our strip centers are adding new business, and there are new commercial and industrial buildings being built. This says a lot about where we all live and shop; Troy Township is desirable place to be.

In August of ever year, if your property has been reassessed, you will receive a revised assessment notice from Will County. The notice will illustrate the prior year's value in one column and the new value in another. It will also illustrate the percentage of change. This notice is full of valuable information regarding the assessment, your market value, exemptions, and information on how to appeal your value. Please take a moment to read it in its entirety.


After you receive your notice (again you will only receive a notice if your value has changed) if you do not believe the market value placed on your property is correct you may appeal the value. The market

value that has been placed upon your property is the responsibility of my office. The Assessor does NOT tax you! The only way you can appeal your property taxes is to pay under protest. Information on this can be found by calling the Circuit Clerk at 815-727-8592. If you did not receive a notice regarding your value in August because the value did not change, you may still appeal the value. You can contact my office for the current value or check it on the Will County Supervisor of Assessments website at www.willcountysoa.com.

If you wish to appeal your value please contact us prior to filing an official appeal with the Will County Board of Review. It is possible that we may be able to work with you. Of course, if we cannot, you will still have your opportunity to file with the Board of Appeals as long as they have the necessary information in time. You only have 30 days to file with the Board of Review, so the sooner you get your appeal to us – the better. You can refer to our website at www.troytownship.com under the Assessor section and read how to appeal your assessment. We would be more than happy to assist you with any and all instructions either for us or for the Board of Review.

I always encourage all property owners in the Township to review their property record cards to ensure there are no errors. We have hard copies in our office and property information is available on line at www.troytownship.com under the Assessor tab – Property Search. Please note: the online search can be sensitive when searching by address. Please only enter the street name then choose the proper address from the list. If you are searching by pin number please do not include the 05 – begin with the 06 number then continue with the remainder of the pin number. If you would find an error, please contact my office immediately.

There are number of exemptions available to you if you are the owner, reside in the home, and are responsible for continued on page 3

the payment of property taxes. Possible exemptions include: General Homestead, Home Improvement, Senior Homestead, Senior Assessment Freeze, Disabled Persons, Returning Veteran, and Disabled Veteran. There are varying degrees of information that is required for each of these exemptions. Please refer to our website under the Assessor Tab – Exemptions to see if you qualify.

If you are currently receiving the Senior Assessment Freeze, the forms will be mailed at the end of March and will be gray in color. If you will be coming into our office for assistance in filling out this form please wait until your income taxes are completed and bring the gray form and a copy of your income taxes with you. A representative from Will County will be in our office on April 20th from 10:00 a.m. until 2:00 p.m. to assist us with freeze forms. If you cannot make it on that day, we are happy to assist you when you are able to come in. Our office hours are from 8:00 a.m. until 4:00 p.m. Monday through Friday. No appointment is necessary. If you are not currently receiving the Senior Assessment Freeze and would like to know if you qualify, please contact my office at 815-744-5806 and have a copy of your 2016 income tax forms available.

As always, it is my pleasure to serve the residents of Troy Township as your Highway Commissioner. This past winter has been a mild one which allowed us to save on our salt usage. Crews have been spending time working on equipment to prepare for the spring and summer construction season. As the weather warms up you will see the Troy Highway Department working on addressing water and ditch issues. We are hopeful for a dry summer to allow us to complete these much needed projects that we were unable to finish last season.

You can always do your part to help us achieve positive drainage in the ditches and culverts. It is important that these areas remain free and clear of debris. Please make it a point to regularly clean out debris from the ditch and culvert area in your front yard.

It has been a year now since the electronic recycling program ended at the Troy Township Highway Department. While our recycling center continues to collect traditional recycling



(paper, plastic, cardboard), textile recycling, and car batteries **we DO NOT accept any electronic recycling**. Will County has implemented a new electronic recycling program with various locations. SERVICES FOR UNINCORPORATED AREAS OF TROY TOWNSHIP

Annual Spring Clean Up April 17th through April 21st

Troy Township Highway crews will be picking up household items such as furniture, appliances, carpet (tied in rolls), etc. for residents in <u>unincorporated</u> Troy Township. Place items out in front of your residence near the road. Remember that Friday, April 21st will be the last day for pick-ups. Please do not mix your everyday garbage, twigs, grass, etc. in

with the items being picked up during Spring Clean Up week. We will not pick up paints or liquids of any kind as they will break and spill out of our equipment. We will **NOT** pick up any electronics such as TVs, computers, etc. Again, we have no way to handle garbage or papers so PLEASE....NO GARBAGE OR PAPERS!

Branch and Brush Pick Up

Beginning May 1st and continuing through November 6th on the first and third Monday of the month, branch and brush pick-up will resume for the <u>unincorporated</u> areas only of Troy Township. If a holiday falls on any of these Mondays, pick up will be the following day. Please

Shredding Event and Medication Disposal May 6th

Join us on Saturday, May 6, 2017, from 9:00 a.m. - 11:00 a.m. when Troy Township will host its next semi-annual shredding event. Troy Township residents can bring their personal papers and documents to the township parking lot on the west side of the township offices and community center to be shredded by ShredX. Each resident must show proof of township residency and is allowed to have two letter size file or copy paper boxes shredded.

Troy Township is proud to once again partner with the Shorewood Police Department and will be offering medication disposal along with the shredding event. Township residents can bring their unneeded medication so that it can be disposed of properly. Make sure to bring only residentially generated medication items. No medications from businesses or doctor's offices will be accepted. Use a permanent marker to black out your name or personal information on the label.

NEEDLES APPROPRIATELY CONTAINED

WITHIN AN APPROVED SHARPS CONTAINER WILL NOW BE ACCEPTED AT THE EVENT! Chicago Crime Scene Cleanup has agreed to partner with us and will be onsite to collect and properly dispose of the needles. IMPORTANT....only needles that are properly contained within an approved sharps container will be accepted. You can purchase approved sharps containers at most drug stores or pharmacies.

Troy Township to Host AARP Driver Safety Program Course

Troy Township will host an AARP "Smart Driver" Driver Safety Program for Troy Township seniors. Under Illinois law, those above age 55 - whether AARP members or not - qualify for a worthwhile multi-year auto insurance discount* by completing this course. *Please check with your insurance company for the exact discount and the correct procedure to obtain it.

Studies have shown that fewer fatal and injury-causing crashes and fewer violations occur among drivers who have taken this nationally-recognized course. Upon completion of the course, each attendee is

awarded a certificate.

This is a two-day course and participants must attend both classes to be awarded the certificate. Class dates are Tuesday, August 8th and Tuesday, August 15th from 11:00 a.m to 3:00 p.m. both days. Both classes will be held at the Troy Township Community Center, located at 25448 Seil Road in Shorewood. The cost of the course is \$20.00, but AARP members pay only \$15.00.




On the second Thursday of even months, Troy Township will have a "Game Day" which will feature a different type of game and will start at 1:30 p.m. Light refreshments will be served.
