## A MESSAGE FROM SUPERVISOR **Joseph D. Baltz**

On April 6, 2021, the Consolidated Election took place where you, the township voters, elected the new township board. The board was elected with terms for the Supervisor, Highway Commissioner, Clerk, and Trustees beginning May 17, 2021, and the terms for the Assessor and Collector beginning January 1, 2022. I would like to express my sincere appreciation for having been elected to my 10th term as Troy Township Supervisor. It is my honor to serve in this position and having served as the Township Supervisor since 1984, I have witnessed my share of natural disasters hit our Township. When disasters like the Plainfield tornado in 1990 and the July 1996 flooding hit our area, I can tell you that the Township was there to support our residents. Living through Covid is no different. We know that many households have been hit hard and are still financially trying to recover from the impact of the shutdown, lost wages, illness and more. We are here to help. The Township has two financial programs to assist residents: General Assistance and Emergency Assistance. Both programs come with income and asset qualifications but can be a source of help for some qualified residents. We are also a Salvation Army Service Extension Office and administer Nicor Sharing assistance. Our Community Services Director, Angela Scaggs, can talk with you about all these programs and can be a referral source to other social service agencies in our area. During my time serving as Township Supervisor, I have also witnessed my share of growth and progress throughout the community. From the building of the Township Office and Senior Center in 1985 to the building renovation/expansion in 2006 adding the Community Center; from the creation of casinos on the river to the housing boom of the early to mid-2000's; the landscape that makes up Troy Township is ever evolving.

This trend will continue as some major road infrastructure projects are starting or are currently under development that will forever change how traffic moves through the area. Please see the road project graphic on page 5 for more details.

## NEWS FROM ASSESSOR **Kim Anderson, CIAO**

Due to the pandemic all exemptions that required a renewal application have been carried over for another year. **I urge everyone to check their property tax bills that were received in May and also those that will be sent out next year to make sure you are receiving all the exemptions you are entitled to.** Please note if you move into a new home, exemptions do not follow you – you MUST reapply. If you need assistance, please do not hesitate to call the assessor's office at 815-744-5806.

If you have not applied for any exemptions that you are entitled to, you must do so prior to November 2021 in order to receive the reduction on your property tax bill. The following exemptions are available and must be applied for: Senior Homestead Exemption, Senior Assessment Freeze, Disabled Persons Exemption, Disabled Veteran Exemption, and Returning Veteran Exemption. 2021 valuation of the Township's properties was completed in June and reassessment notices were mailed the first week of August. If you did NOT receive a reassessment notice, your property was not reassessed for 2021. Troy Township's overall value increased just shy of 3%. As am I sure everyone knows, the residential real estate market has been and still is going crazy. Higher values are attributed to the lack of inventory and low-interest rates. It will be interesting to see if there will be any change in the coming year. Commercial property sales were pretty much stagnant due to the uncertainty the pandemic may still cause.

If you plan to visit our office anytime in the near future, please note that a mask is required for entry into the building. Social distancing will be enforced and please do not come in if you are not feeling well. Most issues do not require a visit to our office and can be taken care of over the phone or via email. Please note that the search function is very sensitive to address searches. Please only enter a street name then hit enter or the "search data" button. A list of addresses will show up, you can then choose the house number you are looking for. ***Please note: our website is under constant updating, if you cannot find what you are looking for, please call or email us.***

The Clerk is responsible for the integrity and preservation of the township records which are all available to you for inspection via the Freedom of Information Act (FOIA).

Troy Township constantly strives for ease of access and transparency with regards to the records our residents may find important. Our website, [www.troytownship.com](http://www.troytownship.com), includes a Transparency Portal that contains items such as: agendas, audits, bid notices, budgets, levies, legal notices, meeting minutes, etc.

Our current website was designed and launched in 2004 and needed technology and feature updates. In March of every even numbered year, residents would be expecting a primary election in advance of the November General Election. Public Act 102-0015 became effective on June 17, 2021, and moves the 2022 Primary Election from March 15, 2022, to June 28, 2022. ## SHREDDING EVENT AND MEDICATION DISPOSAL OCTOBER 2<sup>ND</sup>



Join us on Saturday, October 2, 2021, from **9:00 a.m. - 12:00 p.m.** when Troy Township will host its next shredding and medication disposal event. This event will take place at 25448 Seil Road in

Shorewood. Troy Township residents can bring their personal papers and documents to the township parking lot on the west side of the township offices and community center to be shredded onsite by Iron Mountain. Each resident must show proof of township residency and are allowed no more than **4 grocery bags per vehicle of paper** to be shredded.

***The event will end early due to inclement weather, if the shredding truck fills up or may be cancelled due to COVID restrictions.***

Troy Township is proud to once again partner with the Shorewood Police Department and Bio One to be offering medication and needle disposal along with

the shredding event. Township residents can bring their unneeded medication and/or needles so that it can be disposed of properly. Make sure to bring only residentially generated medication items. No medications or needles from businesses or doctor's offices will be accepted. Use a permanent marker to black out your name or personal information on the label or you may empty all your pills into a Ziploc bag and bring that.

## A MESSAGE FROM HIGHWAY COMMISSIONER **Thomas R. Ward**

I would like to begin by thanking the residents for electing me to serve as your Highway Commissioner for another four years. It is truly my honor to serve in this role and I look forward to working on your behalf throughout this next term.

During the next four years or so there will be a lot of infrastructure improvements in the Troy Township area. We are currently in Phase 1 Engineering for the replacement and relocation of our Shepley Road Bridge over the DuPage River. IDOT is also actively completing engineering work for the replacement of the River Road Bridge over I-80 and the Shepley Road Bridge over I-80. While all three projects are 1 to 5 years away from the start of construction, all three projects will bring much needed infrastructure improvements to our area. Once these projects are complete the Troy Township Highway Department will look at the possibility of asphalt resurfacing in these areas.

Crews have been very busy this summer performing regular maintenance and are continuing with ditch work and culvert replacement.

For our residents in the unincorporated areas, please make sure to read the guidelines for our Leaf Vacuuming program and our Branch Pick-Up program. If the rules of the program are not followed, we will not be able to pick-up the leaves or branches that you leave out. As winter is fast approaching, I remind all residents to be careful when traveling on wet, snowy, and icy roads; especially in the open areas where the salt is not always effective.

### LEAF VACUUMING

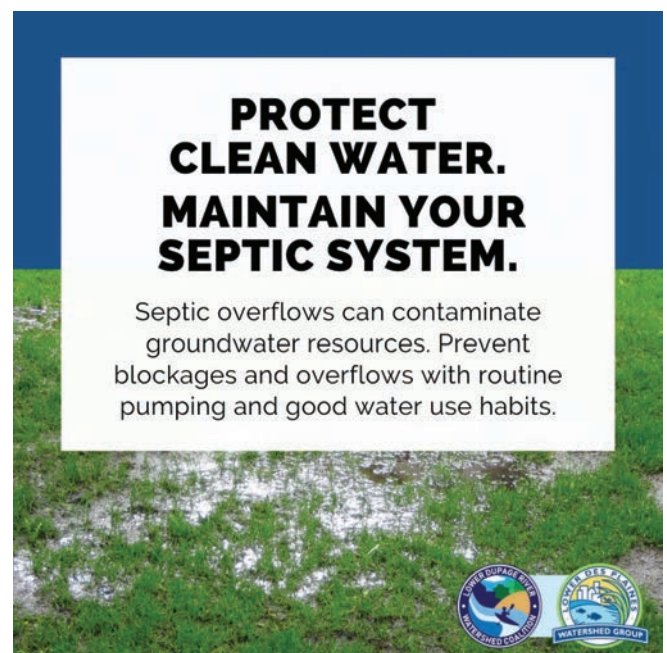
Starting the middle of October through November (specific dates are weather dependent), Troy Township Highway Department will have the leaf vacuuming service for residents in the **unincorporated** areas of the Township. Please **do not bag the leaves**. Residents must rake leaves to the edge of the street so the vacuum machine can reach them easily. **Do not place leaves in ditches as the vacuum cannot reach leaves in ditch areas. Grass cuttings will not be picked up as we have no way of disposing them.** Please be advised that the leaf vacuuming service may be put on hold with the occurrence of a snow or ice event.

### TREE BRANCH PICK-UP FOR UNINCORPORATED RESIDENTS

The final three pick-up dates for the Tree Branch Pick-Up Program in the **unincorporated** areas of the Township will be Monday, October 4th, Monday, October 18th, and Monday, November 1st. ## Mobile Driver Services Unit & I-Cash Coming to Troy Township on Tuesday, October 5th

Troy Township has partnered with State Representative Larry Walsh, Jr. to bring the Secretary of State Mobile Driver Services Unit and I-Cash to the Troy Township Community Center on Tuesday, October 5, 2021. The Community Center is located at 25448 Seil Road, in Shorewood, Illinois. Illinois residents will be able to renew their driver's licenses **(NO behind the wheel driving test offered)**, obtain duplicate or corrected licenses and obtain Illinois identification cards between 10:00 a.m. and 2:00 p.m. **REAL ID's can ONLY be issued at a Secretary of State facility and NOT at the mobile driver services unit event.**

A Rules of the Road Review Course is tentatively scheduled to be held from 10:00 a.m. to 11:30 a.m. The review course combines an explanation of safe driving techniques, Illinois driving laws and a practice written exam. **What is I-Cash:** Unclaimed property consists of accounts and other financial instruments, usually intangible, being held at corporations, financial institutions, financial intermediaries, courts, and life insurance companies, that have gone dormant for a specified period of time based on property type.

Common types of unclaimed property include: checking and savings accounts, uncashed wage and payroll checks, uncashed stock dividends and stock certificates, insurance payments, utility deposits, customer deposits, accounts payable, credit balances, refund checks, money orders, traveler's checks, mineral proceeds, court deposits, uncashed death benefit checks and life insurance proceeds. Unclaimed property does not include real estate or vehicles.

A representative from I-Cash will be assisting those interested in finding out if they have any unclaimed property.

## Illinois Student Assistance Commission (ISAC)- College Financial Aid Process on Thursday, October 7th

As the time for college visits are about to start and the thought of "how are we going to pay for college and what type of aid is available" looms in the back of our minds, Troy Township has partnered with State Representative Larry Walsh, Jr. to bring you a presentation from ISAC. The Financial Aid Process presentation will outline the general financial aid process and will provide insight on how financial aid works, how to apply for it, student eligibility, and how it can be used

to help apply for college. It introduces the Free Application for Federal Student Aid (FAFSA) and the Alternative Application for Illinois Financial Aid, along with summarizing state and federal aid programs among other topics.

# Road Projects

### **I-55, US 52, I-80**

Today you can already see improvements taking place for the Seil Road Interchange at I55. These improvements are part of a larger project called the I-55 at IL 59 Access Project that addresses US 52 from River Road to Houbolt Road, I-55 from I-80 to US 52, Olympic Boulevard from I-55 East Frontage Road to Houbolt Road, and Seil Road from Raven Road to IL 59. ### **Shepley Road Bridge over DuPage River**

Highway Commissioner, Thomas R. Ward, is currently in Phase 1 Engineering studying the replacement of and realignment of the Shepley Road Bridge over the DuPage River. ### **Shepley Road Bridge over I-80 and River Road Bridge over I-80**

IDOT has targeted both the Shepley Road Bridge over I-80 and the River Road Bridge over I-80 for replacement. Those projects are expected to begin construction in one to two years. The Township will share more information as it becomes available to us.

### **Houbolt Road Bridge**

With the creation of The CenterPoint Intermodal Center and the abundance of warehouses in our region, truck traffic has become a major area of concern. Currently under construction is the Houbolt Road Extension. With completion estimated in 2023 this project will forever change how truck traffic travels throughout our region and specifically to and from The CenterPoint Intermodal Center. ### **Rt. 52 and County Line Road**

The intersection of Rt. 52 and County Line Road on the Township's western border has long been a location of concern.
