<u>HIGHWAY DEPARTMENT REPORT</u>: Deputy Clerk Dylik reported for Highway Commissioner Ward:

- Recent purchase of two 40' container boxes. Utilized for storage of small implements that otherwise may be outside. The boxes will increase the longevity of the equipment and tools.
- Installation of a catch basin at the corners of County Farm Rd. and Rock Run Dr.
- The leaf vacuum program is in full swing. One of the leaf vacs had a bearing fail on 11/15/21. Crews removed the faulty bearing and are awaiting UPS shipment. The repair left crews slightly behind, but the goal is to have it running after lunch tomorrow.
- Two trucks have been set up for snow removal so the leaf pick-up needs to be completed fast. Crews will be ready when the snow sticks.

ASSESSOR'S REPORT: Deputy Clerk Dylik reported for Assessor Anderson:

- The 2021 Board of Review hearings were finalized on Monday, November 8, 2021. The results will be received at the end of January or the first part of February.
- A posting for employment openings went on the Township website, as well as an E-Blast, for full-time and part-time positions. There is a retirement coming up in 2022, and a need to fill a vacated position from 2 years ago. A heavy amount of new construction creates a need for staff on field work and property maintenance.
- Since appeals have ended, more time will be devoted to property maintenance and field checking.
