GUESTS AND CITIZEN COMMENTS:

Supervisor Baltz opened the meeting for the introduction of guests and citizen comments.

After asking a third time, and hearing none, Supervisor Baltz closed the meeting for citizen comments.

REPORTS OF TRUSTEES / COMMITTEES:

TRUSTEE JOHNNIE GREENWOOD – No report.

HIGHWAY DEPARTMENT REPORT: Commissioner Ward reported the following:

- An abbreviated “leaf pick-up” may be performed in the coming days due to the program on hold after inclement weather Fall 2021. Possibly a vac & loader will be used without mounting boxes.
- Snow equipment will be removed in the coming weeks.
- Spring Clean-up is scheduled for April 18 – 22.
- Salt usage came in under estimates.

ASSESSOR’S REPORT: Administrator Dylik presented Assessor Kim Anderson’s report:

- As of Friday (2-25-2022), the Troy Township Assessors Office has not received a “final factor” from Will County. As a reminder, an increase of 4.24% is the current estimated rate.
- Does not appear that property tax exemptions will be rolled over like the past 2 years. Will County stated that revised exemption applications will be loaded onto their website for retrieval.
- Troy Township will be hosting an “exemption event” that covers initial sign-up and renewal processes. It will take place at the Community Center on May 10 from 9:00am to 3:00pm. Notice will be posted on the website, Facebook, and eblast.
- There is still an active staff member search for the Assessor’s Office. Avenues such as Indeed, Will County Workforce, Facebook, Township Website, and Temp Agencies are being pursued.

TOWNSHIP CLERK REPORT: No report.

SUPERVISOR’S REPORT: Supervisor Joseph Baltz reported the following:

ADMINISTRATOR’S REPORT: Administrator Dylik reported the following:

- Regarding 4817 Frank Drive, the next scheduled court date is Tuesday, March 22, 2022. Findings will be updated at the April Board Meeting.
- Regarding the Shepley Road Bridge Project, Willett-Hoffmann has updates as of March 9, 2022:
 - 1) Pre-Final 4f de minimis evaluation and report is submitted to IDOT and includes the Will County Forest Preserve correspondence.
 - 2) The Project Development Report (PDR) is nearing completion and will address the service road design.
 - 3) The Project has Biological, cultural, and wetland clearances for design approval.
 - 4) The geotechnical consultant will complete drilling work which will assist design.

- 5) Meeting with ComEd's Engineering Consultant to complete the permit process.
 - 6) Design approval is slated for 6/8/2022 and the target letting date is 3/10/2023.
 - 7) Willett-Hoffmann will host a public meeting on the project April 5th from 5:00pm – 7:00pm at the Community Center.
- Open Meetings Act training needs to be completed and the certificate forwarded to Admin. Dylik.
 - The 2022 Troy Township Newsletter has been distributed and available for review.

Supervisor Baltz inquired about IDOT updates on the Route 52 and County Line Road intersection improvements. Administrator Dylik reported they are collecting "Public Comments" on the matter and website links can be forwarded.

OLD BUSINESS:

Supervisor Baltz asked for any old business. After asking for a third time, no old business was presented.

- C) Approval of **Resolution 21-22R-17 Transfer of Appropriations for the Fiscal Year ending March 31, 2022 – General Town Fund including Assessor's Budget.** After asking for discussion (none), a motion was made by Trustee Greenwood; seconded by Trustee Wheeler to approve **Resolution 21-22R-17.**

- D) Approval of **Resolution 21-22R-18 Transfer of Appropriations for the Fiscal Year ending March 31, 2022 – General Assistance Fund.** A motion was made by Trustee Nudera; seconded by Trustee Kopman to approve **Resolution 21-22R-18.**
Roll call vote: Greenwood-Aye; Kopman-Aye; Nudera-Aye; Wheeler-Aye; Baltz-Aye.

- E) Approval of **Resolution 21-22R-19 Establishing the Benefit Levels and the 2022-2023 Budget Allocation Amounts for Emergency Assistance.** After asking for discussion, Admin. Dylik clarified there is a \$2,500 maximum, and the Township is enhancing the application process for assistance and using our Salvation Army credentials to assist people. Increasing income limits and our payment levels will allow the Township to assist more individuals.
A motion was made by Trustee Kopman; seconded by Trustee Wheeler to approve **Resolution 21-22R-19.**

- F) Adoption of **Ordinance 21-22-20 – Issuance of Permits for Overweight and Over-dimension Vehicles.** After asking for discussion, Highway Comm. Ward commented that vehicles or

equipment over 80,000lbs., over-dimension, overweight on the axle will submit to an outside service that is currently free (and used by govt. entities) to administer the permitting process. Admin. Dylik & Ward commented that the Road District will be able to better regulate, track, and recapture revenue through the service to maintain & repair the affected roads. A motion was made by Trustee Kopman; seconded by Trustee Nudera to approve **Ordinance 21-22-20**. Roll call vote: Greenwood-Aye; Kopman-Aye; Nudera-Aye; Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion carried.

- G) **Travel Expense Approval for Assessor Kimberly Anderson** for the IPAI Conference in Bloomington, IL, April 8, 2022, for Hotel Costs of \$124/night plus tax for three nights and meal per diems totaling \$180.00. A motion was made by Trustee Wheeler; seconded by Trustee Greenwood for the submitted **Travel Expense Approval for Assessor Kimberly Anderson**. Roll call vote: Greenwood-Aye; Kopman-Aye; Nudera-Aye; Wheeler-Aye; Baltz-Aye. 5 Ayes, 0 Nays, 0 Absent. Motion carried.
