HIGHWAY DEPARTMENT REPORT: Highway Commissioner Ward presented the following:

- Crews will be "crack sealing" for preventative maintenance in the coming weeks.
- Routine/scheduled replacement of drainage culverts and ditch work are ongoing.
- Concrete sidewalk repair to begin in Longleat Subdivision and Sarver Dr.
- Building Project (Siding, gutters, fascia, etc.) is complete on all affected buildings.

ASSESSOR'S REPORT: Administrator Dylik presented on behalf of Assessor Anderson:

- A second round of "reassessments" were completed and submitted to the County on June 15th.
 Each neighborhood, including commercial, industrial, farm, and vacant land, was reviewed. A slight increase for industrial parcels, and increases were minimal for commercial because of COVID 19 timeframe. These values are based upon the last 3 years of sales and related information.
- The "exemption event" held at the Township was well attended, with the County processing approximately 130 applications. The Assessor's Office has currently processed 651.
- Appeal season will begin August 9, 2023, when notices go to publication. After hours appointments will be offered August 17, 24, & 31 from 4pm 6pm.
- Staffing issues in the Assessor's Office are becoming a concern. Employee retainage is a topic of discussion with Administrator Dylik and attempting to resolve the turnover issue.

TOWNSHIP CLERK REPORT: No report.

SUPERVISOR'S REPORT: Supervisor Baltz elected to present the Administrator's Report.

ADMINISTRATOR'S REPORT:

- Willet Hoffman's, Doug Brunot, reported the Shepley Road Bridge Project Design Variance was approved June 8, 2023. The final Project Development Report will be completed this month.
- The Road District is in the process of finalizing an engineering agreement with Willett Hoffman for the Ron Lee Estates Storm Sewer Replacement Project. The County's Infrastructure Pillar awarded an additional \$201,415 bringing the total project to \$400,000.
- Logan Kantorski's Eagle Scout Project has been finalized and approved by all parties. A copy of the bench design was attached for viewing.
- Data on FOIA requests and Financial Assistance were presented to the Board. This includes a brief history, as well as the current year's figures.
- The TOI Annual Conference in Springfield, IL is from November 12th through the 14th. Please RSVP by October 1.
- Submissions of newsletter articles for the fall edition will be around August 1st.
