

**Minutes of the Troy Township Public Hearing**  
**Monday, December 18, 2023**  
**7:15 pm**

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois. The public hearing is for the **2023 Town Fund Levy Ordinance 23-24-12**. The property taxes levied for in 2022 will be extended to the Troy Township Town Fund during fiscal year 2023-2024.

Clerk Larry Ryan called the meeting to order at 7:15pm.

In the absence of Supervisor Baltz, Clerk Ryan acknowledged a motion before the Board to select Trustee Bryan Kopman to act as a “Chairman Pro-Tem” of the Public Hearing. The motion was made by Trustee Greenwood; seconded by Trustee Nudera to designate Trustee Kopman as the Administrator of the Public Hearing.
