

**Minutes of the Troy Township Public Hearing**  
**Monday, December 18, 2023**  
**7:00 pm**

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois. The public hearing is for the **2023 Road District Levy Ordinance 23-24-11**. In the absence of Supervisor Baltz, Clerk Ryan considered a motion before the Board to select Trustee Bryan Kopman to act as a “Chairman Pro-Tem” of the Public Hearing. **Presentation of the 2023 Road and Bridge Fund Levy Ordinance 23-24-11**

Chairman Kopman opened the floor for discussion;

- Clerk Ryan gave a brief history of the presentation and discussion that took place at the November Finance Committee Meeting, continued at the November 20, 2023, Board Meeting, and for a third time during this Public Hearing.
- Chairman Kopman reiterated the unanimous support and recommendations by the Finance Committee in November for the 2023 Road and Bridge Levy.
- Chairman Kopman asked for further discussions from the Board, and none were presented.
