

**Minutes of the Troy Township Public Hearing**  
**Monday, December 16, 2024**  
**7:00 pm**

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois. The public hearing is for the **2024 Road District Levy Ordinance 24-25-09**. The property taxes levied for in 2024 will be extended to the Troy Township Road and Bridge District during fiscal year 2025-2026.

Supervisor Baltz called the meeting to order at 7:00pm.

**Acknowledgement of Publication of Public Hearing Notice**

Supervisor Baltz and Clerk Ryan confirmed there was a Publication of Public Hearing Notice advertised in the Herald News on December 5, 2024. A copy of the Publication is placed on file.

**Presentation of the 2024 Road and Bridge Fund Levy Ordinance 23-24-11**

Supervisor Baltz opened the floor for discussion:

- Finance Chairman Kopman reiterated the unanimous support and recommendations by the Finance Committee in November for the 2024 Road and Bridge Levy. The Levy includes a proposed increase of 5.57% over last year, and the ½ share Troy Township Road Dist. receives = 53.5% on average. The proposed amount typically falls short of the “actual” distributed amount.
- Supervisor Baltz asked for further discussions from the Board, and none were presented.

Supervisor Baltz asked if there were any comments or questions from the public. After asking for a third time, and hearing none, the meeting was closed for public comments.
