# Minutes of the Troy Township Public Hearing Monday, December 16, 2024 7:15 pm

#### **Acknowledgement of Publication of Public Hearing Notice**

Supervisor Baltz and Clerk Ryan confirmed there was a Publication of Public Hearing Notice advertised in the Herald News on December 5, 2024. A copy of the Publication is placed on file.

### Presentation of the 2024 Town Fund Levy Ordinance 24-25-10

Supervisor Baltz opened the floor for discussion:

- Chairman Kopman added that the 2024 Levy was reviewed and recommended by the Finance Committee. The Levy proposes a 5.57% increase over last year, and that equates to a 6.3% decrease in the tax rate. Reasoning behind the Levy amount involves financial stability, proposed capital needs, not receiving 100% of the amount requested, and relation to the preliminary "new construction" values. The figures have not changed since the November Finance Committee meeting.
- Supervisor Baltz asked for further discussion or concerns from the Board, and none were presented.

Supervisor Baltz asked if there were any comments or questions from the public. After asking for a third time, and hearing none, the meeting was closed for citizen comments.
