

Minutes of the Troy Township Public Hearing
Monday, April 21, 2025
7:00 pm

Troy Township Public Hearing held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Baltz stated that this public hearing is for the fiscal year 2025-2026 Road District Budget and Appropriation Ordinance 25-26-01, and for the fiscal year 2025-2026 Township Budget and Appropriation Ordinance 25-26-02.

Supervisor Baltz called the meeting to order at 7:00 p.m.

The Pledge of Allegiance was recited and led by Clerk Larry Ryan.

Supervisor Baltz asked for any citizen comments. After asking for a third time, the meeting was closed for citizen comments. No citizen comments were made.

Supervisor Baltz opened the meeting for review of the Road and Bridge Budget and Appropriation **Ordinance 25-26-01**. Finance Committee Chair Kopman confirmed that the previous committee meeting had provided thorough review and received unanimous support of the Road District Budget Proposal. No additional comments or questions were made regarding the 2025-26 Road and Bridge Budget.

Supervisor Baltz focused the meeting on the review of the Town Fund Budget and Appropriation **Ordinance 25-26-02**. Finance Committee Chair Kopman confirmed that the Committee had met and reviewed the Town Fund Budget Proposal which was approved unanimously for recommendation to the Board. No additional comments or questions were made regarding the 2025-26 Town Fund Budget.

Supervisor Baltz had incorporated the following items for action:

VII) Action to adopt Ordinance 25-26-01, an Ordinance Appropriating for all road purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2025, and ending March 31, 2026 [as presented, total budget appropriations were \$2,086,240.00]. A motion was made by Trustee Kopman; seconded by Trustee Nudera to adopt **Ordinance 25-26-01**.

Roll call vote: Greenwood – Aye; Kopman – Aye; Nudera – Aye; Wheeler–Aye; Baltz–Aye.
5 Ayes, 0 Nays, 0 Absent. Motion Carried.

VIII) Action to adopt Ordinance 25-26-02, an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2025, and ending March 31, 2026 [as presented, budget appropriations were \$1,877,735.00 for the Town Fund, \$29,885.00 for the General Assistance Fund, \$170,000.00 for Capital Projects Fund for a total of \$2,077,620.00]. A motion was made by Trustee Wheeler; seconded by Trustee Greenwood to adopt **Ordinance 25-26-02**. Roll call vote: Greenwood – Aye; Kopman – Aye; Nudera – Aye; Wheeler–Aye; Baltz–Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.

Supervisor Baltz asked for further discussion, and there were no other concerns or questions brought before the Board.

Motion made by Trustee Greenwood; seconded by Trustee Nudera to adjourn the Public Hearing. Roll call vote: Greenwood – Aye; Kopman – Aye; Nudera – Aye; Wheeler–Aye; Baltz–Aye. 5 Ayes, 0 Nays, 0 Absent. Motion Carried.
