

**Minutes of the Troy Township Board Meeting**  
**Monday, March 16, 2026**  
**7:00 p.m.**

A meeting of the Troy Township Board of Trustees was held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Baltz called the meeting to order at 7:00 p.m.

**GUESTS AND CITIZEN COMMENTS:**

Supervisor Baltz opened the meeting for the introduction of guests and citizen comments.

- Doug Butalla, Will County Chief Supervisor of Assessments, opened with an introduction of Kim Anderson’s dedication to the role of Assessor from 2012-2026. **REPORTS OF TRUSTEES / COMMITTEES:**

**TRUSTEE JOHNNIE GREENWOOD** – No report.

**TRUSTEE BRYAN W. KOPMAN** – Report submitted to Trustee Nudera.

**TRUSTEE JERRY NUDERA** – Happy St. Patrick’s Day. Reported on behalf of Trustee Kopman with regard to the Finance Committee review of the 2026-27 Fiscal Year Annual Budget:

- Commended the input from Admin. Dylík, Elected Officials/Dept. Heads that led to a detailed and thorough proposal. Admin. Dylík walked the Committee through the Budget and answered all questions.
- The Finance Comm. voted unanimously to recommend to the Board approval of the following budgets: 2026-2027 Town Fund & Assessor’s/Town Capital Projects/General Assistance/Road & Bridge.

**TRUSTEE BRETT WHEELER** – No report.

**HIGHWAY DEPARTMENT REPORT:** No report.

**ASSESSOR’S REPORT:** Assessor Kimberly Anderson presented the following:

- Four applicants from the Will County CED program will be interviewed in the coming weeks.
- Will County SOA Staff will be holding an “Exemption Event” April 28<sup>th</sup> 10am to 2pm at the Community Center. They will assist with paperwork. Renewal applications will be mailed on April 10<sup>th</sup>.
- Auburn Chase Subd. (Seil Rd.) = 4 permit applications received / approx. 277 homes proposed. Shorewood Town Center II = 4 permit app. Received / approx. 139 single family homes slated. The Hamptons Subd. (Wynstone & 52) = 0 permits / approx. 268 rental houses/townhouses planned.
- This being her last meeting, Assessor Anderson thanked everyone for the support of her and her staff over the years; the progress they have made could not have been possible without it. She is immensely proud of having been involved with township government and knows firsthand the excellent work that townships perform. She knows Nick Surges will do an exceptional job as the new Assessor.

**TOWNSHIP CLERK REPORT:** Larry Ryan presented the following updates on the Single Waste Hauler Committee:

- The Primary Election will be held March 17<sup>th</sup>, and the “unincorporated” households in Troy Twp. will have an opportunity to weigh-in on the Referendum Question. Everyone involved is excited to see which outcome the Single Waste Hauler results will bring. Hoping our outreach educated the residents.
- Assessor Anderson commented on the “Yes or No” majority. Dylík & Baltz confirmed the households at 1,300+/- and will monitor the results as soon as they become available.

A motion was made by Trustee Greenwood; seconded by Trustee Nudera to approve **Tentative Ordinance 25-26-25** as presented. No further concerns were presented.
