

Minutes of the Troy Township Public Hearing
Monday, April 20, 2026
7:00 pm

I) Call to Order

Troy Township Public Hearing was held at the Troy Township Community Center, 25448 Seil Road, Shorewood, Illinois.

Supervisor Baltz stated that this public hearing is for the fiscal year 2026-2027 Road District Budget and Appropriation Ordinance 26-27-01, and for the fiscal year 2026-2027 General Town Fund Budget and Appropriation Ordinance 26-27-02.

Supervisor Baltz called the meeting to order at 7:00 p.m.

II) Pledge to the Flag

The Pledge of Allegiance was recited and led by Trustee Johnnie Greenwood.

III) Roll Call

IV) Guest and Citizen Comments

Supervisor Baltz asked for any citizen comments. After asking for a third time, the meeting was closed for citizen comments. No citizen comments were made.

V) Review of Fiscal Year 2026-2027 Budget and Appropriations Ordinances

Supervisor Baltz turned the meeting over to Finance Committee Chairman Brian Kopman for review of the Budget Ordinance.

Finance Committee Chairman Kopman opened the meeting for review of the Road and Bridge Budget and Appropriation **Ordinance 26-27-01** commenting that the Finance Committee had met and thoroughly reviewed the proposed R&B budget which was approved unanimously for recommendation to the Board. The Board then passed the tentative budget ordinance at the March meeting. The tentative budgets (R&B and Town) approved by the Board in March included an increase to the line item of health insurance to allow for a possible 20% increase in health insurance costs. Administrator Dylík confirmed that there were no changes from the tentative budgets (R&B and Town) approved by the Board in March to the budget ordinances being presented today other than the final ending cash balances for the fiscal year ending March 31, 2026. No additional comments or questions were made regarding the 2026-27 Road and Bridge Budget.

Finance Committee Chairman Kopman opened the meeting for the review of the Town Fund Budget and Appropriation **Ordinance 26-27-02**. Finance Committee Chairman Kopman confirmed that the Committee had met and reviewed the Town Fund Budget Proposal which was approved unanimously for recommendation to the Board.

No additional comments or questions were made regarding the 2026-27 Town Fund budget. Kopman also reviewed the Assessor's budget, GA budget, and Capital Projects Fund budgets noting that all were reviewed and approved by the Finance Committee and the tentative budgets for each were approved by the Board at the March meeting. No additional comments or questions were made regarding the 2026-27 Town Fund budget, Assessor's budget, GA budget, or Capital Projects Fund budget.

VI) Discussion

Discussion was allowed during item V on the agenda. Supervisor Baltz asked for further discussion, and there were no other concerns or questions brought before the Board.

Supervisor Baltz presented the following items for action:

VII) Action to adopt Ordinance 26-27-01, an Ordinance Appropriating for all road purposes for Troy Road District, Will County, Illinois, for the fiscal year beginning April 1, 2026, and ending March 31, 2027 [as presented, total budget appropriations were \$2,531,350.00]. A motion was made by Trustee Kopman; seconded by Trustee Nudera to adopt **Ordinance 26-27-01**, as presented.

VIII) Action to adopt Ordinance 26-27-02, an Ordinance Appropriating for all Town Purposes and General Assistance for Troy Township, Will County, Illinois, for the fiscal year beginning April 1, 2026, and ending March 31, 2027 [as presented, budget appropriations were \$2,595,000.00 with \$2,097,630 for the Town Fund, \$37,370.00 for the General Assistance Fund, \$460,000.00 for Capital Projects Fund]. A motion was made by Trustee Nudera; seconded by Trustee Greenwood to adopt **Ordinance 26-27-02**, as presented.


